“92% Target Perolehan Kontrak Baru PPRE Tercapai Pada Juli 2021”

Jakarta, 4 Agustus 2021 – Kontrak baru PT PP Presisi Tbk telah mencapai 92% hingga Juli 2021 yaitu sebesar Rp 3.387 triliun dari target total kontrak baru 2021 sebesar Rp3.674 triliun. Pencapaian kontrak baru tersebut tumbuh 256% yoy dari pencapaian kontrak baru hingga Juli 2020 (Rp1.322 triliun).

Pada bulan Juli 2021, Perseroan berhasil menambah perolehan kontrak baru sebesar Rp 584miliar yang didapatkan antara lain dari: Proyek Rehabilitasi Pamanukan – Palimanan (PUPR – non group) sebesar Rp 66.564 miliar, Proyek Pekerjaan Jalan KIT Batang 1.4 (PP KSO - group) sebesar Rp 39.195 miliar, Proyek Pekerjaan Hauling Road Upgrading Biri – Biri (Weda Bay Nickel – non group) sebesar Rp 51.490 miliar, Proyek Pekerjaan Jasa Hauling Nickel (Weda Bay Nickel – non group) sebesar Rp 355.680 miliar, serta kontribusi dari Entitas Anak PT LMA pada Proyek Pembangunan Junction Cisumdawu 1 (PP - group) sebesar Rp 42.072 miliar.

Secara komposisi per lini bisnis, pencapaian tersebut masih didominasi oleh lini bisnis Civilwork sebesar 60%, Mining Services 31%, Production plant 6% dan sisanya dari Structure Work maupun Rental Heavy Equipment. Pencapaian kontrak baru tersebut juga merupakan upaya yang terus dilakukan Perseroan dalam melakukan diversifikasi pada jasa pertambangan, dengan terus meningkatnya komposisi kontribusi jasa tambang pada pencapaian kontrak baru.

“Pencapaian tersebut tentunya meningkatkan *positioning* Perseroan sebagai kontraktor jasa tambang nikel maupun *main-contractor* pada pekerjaan *civilwork*. Selain itu, *competitiveness* perusahaan juga meningkat dengan diperolehnya pasar-pasar baru diluar *group* sebesar 87% dari total kontrak baru yang diperoleh hingga Juli 2021”, ujar Rully Noviandar Direktur Utama dengan bangga.

“Disamping untuk menciptakan keunggulan baru lewat strategi optimalisasi alat berat yang kami miliki, masuknya PP Presisi pada jasa pertambangan juga turut serta dalam program strategis pemerintah yaitu peningkatan produksi serta hilirisasi tambang mineral khususnya nikel”, ujar Darwis Hamzah, Direktur Operasi pada kesempatan berbeda.

“Dengan telah didapat dan berjalannya dua pekerjaan besar pada jasa tambang nikel yakni jasa tambang nikel Morowali dan jasa tambang nikel di Weda Bay Nickel, Halmahera, peluang untuk meningkatkan pertumbuhan perseroan sebagai kontraktor nikel tentunya semakin terbuka lebar”, tutup Rully dengan mantap.

“PPRE Acquired 92% of New Contract Target by End of July 2021”

Jakarta, August 4, 2021 – PT PP Presisi Tbk's new contract has reached 92% until July 2021, valued IDR 3,387 trillion of the total target of new contracts in 2021 (IDR 3,674 trillion). The new contract acquisition growth 256% yoy from the achievement of new contracts on July 2020 (Rp 1.322 triliun).

In July 2021, the Company acquired new contracts valued of Rp 584 billion, which obtained from: the Pamanukan – Palimanan Rehabilitation Project (PUPR – non group) of Rp 66,564 billion, the Batang 1.4 KIT Road Works Project (PP KSO - group) of Rp. 39,195 billion, the Hauling Road Upgrading Biri – Biri (Weda Bay Nickel – non group) project of Rp 51,490 billion, the Hauling Nickel (Weda Bay Nickel – non group) work project of Rp 355,680 billion, and contributions from the Subsidiary PT LMA in The Cisumdawu Junction 1 Development Project (PP - group) amounting to Rp 42,072 billion.

In terms of composition per line of business, this achievement still dominated by the Civilwork business line by 60%, Mining Services 31%, Production plant 6% and the rest from Structure Work and Heavy Equipment Rental. The achievement of new contract acquisition also an effort to continue its diversification strategy in mining services, by continuously increasing the mining services contribution from total new contract acquisition.

“This achievement certainly improves the Company's positioning as a nickel mining service contractor and main contractor in civil work. In addition, the company's competitiveness has also increased with the acquisition of new markets outside the group reached 87% of the total new contracts acquisition until July 2021,” said Rully Noviandar, President Director proudly.

“In addition to create new advantages through our heavy equipment asset optimization strategy, PP Presisi's involvement in mining services also participates in the government's strategic program to increase national nickel production and downstreaming of mineral mines, especially nickel,” said Darwis Hamzah, Director of Operations on a different occasion.

“With the acquisition and progress of two major projects in nickel mining services, namely Morowali nickel mining services and nickel mining services at Weda Bay Nickel, Halmahera, the opportunity to increase the company's growth as a nickel contractor is certainly wide open,” concluded Rully firmly.
