PP Presisi Memperoleh Fasilitas Perbankan Di tengah Pandemi

Jakarta, 25 Agustus 2021– PP Presisi (PPRE) tetap dapat memperoleh fasilitas perbankan di tengah pandemi dari Bank DKI berupa fasilitas *non cash loan*-Surat Kredit Berdokumen Dalam Negeri (SKBDN) dan *cash loan trade* dengan plafon sebesar Rp200 miliar ber-jangka waktu 12 bulan.

“Perolehan fasilitas pembiayaan berupa SKBDN dan *cash loan trade* dari Bank DKI ini, menandakan bahwa PP Presisi masih memperoleh kepercayaan besar dari perbankan di tengah kondisi kinerja industri konstruksi yang masih belum membaik sebagai dampak dari pandemi covid-19 ini, yang ditandai dengan rasio NPL sektor konstruksi di atas rata-rata NPL bank umum”, ungkap Rully Noviandar, Direktur Utama PP Presisi di sela acara penandatanganan fasilitas perbankan tersebut.

“Bukan tanpa alasan jika perbankan masih menaruh kepercayaan kepada PP Presisi di tengah kondisi pandemi yang sulit ini. Perbankan melihat bahwa PP Presisi tetap mampu bertumbuh yang ditandai dengan perolehan kontrak baru per Juli 2021 telah mencapai sebesar Rp3,4 triliun, di atas rata-rata kontrak baru yang diperoleh entitas anak perusahaan konstruksi lainnya, di samping kemampuan PPRE untuk meningkatkan kinerja keuangan serta menjaga kesehatan keuangan. PPRE berhasil meningkatkan Laba Bersih Yang Diatribusikan Kepada Pemilik Entitas Induk sebesar 91% YoY, menjadi Rp35,9 miliar (1H21), dari Rp18,8 miliar (1H20); bahkan berhasil membukukan EBITDA sebesar Rp463 miliar; di samping masih memiliki ruang untuk melakukan leveraging yang cukup besar, mengingat rasio net debt to equity masih di 0,78X”, ujar Benny Pidakso, Direktur Keuangan saat mendampingi Rully.

“Di samping keberhasilan meningkatkan kinerja operasional & keuangan, perbankan tertarik pada rencana bisnis PP Presisi yang akan menjadikan lini bisnis jasa pertambangan sebagai salah satu mitigasi risiko bisnis konstruksi sekaligus sebagai sumber *recurring income* yang akan berkontribusi besar pada kinerja Perseroan di masa depan. Hal inilah mendorong Bank DKI memberikan fasilitas perbankan kepada PP Presisi, yang akan digunakan sebagai alternatif fasilitas pembiayaan dan jaminan keamanan pembayaran sebagai kontraktor jasa pertambangan nikel”, tambah Benny.

Saat ini, Perseroan sedang mengerjakan dua jasa pertambangan nikel yakni sebagai jasa pertambangan (*mining contractor*) pada pertambangan nikel Morowali dan jasa pengembangan tambang (*mining development*) di Weda Bay Nickel. Selain itu, Perseroan juga tengah menggarap beberapa prospek tambahan jasa tambang nikel lainnya.

“Mengacu kepada trend pertumbuhan permintaan nikel yang diikuti oleh trend peningkatan harga komoditas nikel, serta kapasitas dan kapabilitas yang dimiliki Perseroan, kami optimis bahwa lini bisnis jasa pertambangan akan berkontribusi sebesar 20% terhadap target pendapatan Perseroan di tahun 2021 ini”, tambah Rully.

PP Presisi Gets Banking Facilities Amid the Pandemic

Jakarta, August 25, 2021 – PP Presisi (PPRE) can still obtain banking facilities in the midst of a pandemic from Bank DKI in the form of non-cash loan facilities- Domestic Documentary Letters of Credit (SKBDN) and cash loan trade with a ceiling of Rp200 billion with a period of 12 Month.

'The acquisition of financing facilities in the form of SKBDN and cash loan trade from Bank DKI, indicates that PP Presisi still gains great trust from banks in the midst of the construction industry's performance which is still not improving as a result of the COVID-19 pandemic, which is marked by the sector's NPL ratio. Construction above the average NPL of commercial banks", said Rully Noviandar, President Director of PP Presisi on the signing of the banking facility.

"It is not without reason that banks still put their trust in PP Presisi in the midst of this difficult pandemic. Banks see that PP Presisi is still able to grow, which is indicated by the acquisition of new contracts as of July 2021 which has reached Rp3.4 trillion, above the average new contracts obtained by other construction subsidiaries, in addition to PPRE's ability to improve financial performance and maintain Financial health. PPRE succeeded in increasing the Net Profit Attributable to Owners of the Company by 91% YoY, to Rp35.9 billion (1H21), from Rp18.8 billion (1H20); Even managed to record EBITDA of Rp463 billion; In addition, there is still room for considerable leveraging, considering that the net debt to equity ratio is still at 0.78X," said Benny Pidakso, Director of Finance when accompanying Rully.

"In addition to the success of improving operational & financial performance, banks are interested in PP Presisi's business plan which will make the mining services business line one of the risk mitigation measures in the construction business as well as a source of recurring income that will contribute greatly to the Company's performance in the future. This encourages Bank DKI to provide banking facilities to PP Presisi, which will be used as an alternative financing facility and guarantee payment security as a nickel mining service contractor,' added Benny.

Currently, the Company is working on two nickel mining services, namely as a mining contractor at the Morowali nickel mine and mining development services at Weda Bay Nickel. In addition, the Company is also working on several additional prospects for other nickel mining services.

'Referring to the trend of growth in nickel demand which is followed by the trend of increasing nickel commodity prices, as well as the capacity and capability of the Company, we are optimistic that the mining services business line will contribute 20% to the Company's revenue target in 2021,' added Rully.-- end of release --
