PP Presisi dan Anak Usaha Memperoleh Fasilitas Kerjasama Pembiayaan Guna Penyelesaian Proyek Pembangunan Jalan Tol Cinere–Jagorawi Seksi 3

Jakarta, 07 Juni 2022 – PP Presisi (Perseroan) bersama dengan Anak Usaha (PT LMA) memperoleh fasilitas kerjasama pembiayaan berupa fasilitas Kredit Modal Kerja (KMK) dari PT Bank BNI (Persero) Tbk, guna penyelesaian pada Proyek Pembangunan Jalan Tol Cinere–Jagorawi Seksi 3 senilai ±Rp770miliar dengan total nilai kontrak Proyek Jalan Tol Cinere–Jagorawi Seksi 3 sebesar Rp1,2triliun.

“Dengan diperolehnya fasilitas kerjasama pembiayaan berupa fasilitas modal kerja tersebut akan membantu Perseroan dalam mempercepat proses penyelesaian proyek yang direncanakan selesai pada awal kuartal 4-2022 serta menandakan PP Presisi memperoleh kepercayaan besar dari Perbankan dalam pembangunan pekerjaan Proyek Jalan Tol Cinere-Jagorawi Seksi 3 yang diharapkan dapat meningkatkan *competitiveness advantage* Perseroan sebagai Perusahaan Jasa Konstruksi maupun Jasa Pertambangan sebagai kontraktor utama.” ujar Rully Noviandar selaku Direktur Utama PP Presisi.

“Yang kita ketahui Pandemi Covid-19 yang melanda seluruh dunia termasuk Indonesia pada 2 tahun terakhir ini berdampak pada seluruh sektor industri termasuk mundurnya beberapa tender proyek infrastruktur, Proyek Jalan Tol Cinere – Jagorawi Seksi 3 merupakan proyek infrastruktur satu-satunya yang ditenderkan pada tahun 2021. Jalan tol tersebut merupakan bagian dari jaringan Jalan Tol Jakarta Outer Ring Road (JORR) II yang menghubungkan Kukusan–Cinere Depok sepanjang 5,5 kilometer. Sehingga diharapkan dengan selesainya seksi 3 ini, maka jalan tol (JORR) I akan terhubung dengan (JORR) II melalui Jalan Tol Depok–Antasari (Desari) & Jalan Tol Cijago” tambah Rully.

Kedepan kami akan berfokus pada pekerjaan jasa konstruksi maupun non konstruksi melalui sinergi dengan BUMN maupun Swasta, terutama sebagai kontraktor jasa pertambangan dengan mengacu pada trend pertumbuhan nikel dan peningkatan harga komoditas dengan kapasitas dan kapabilitas yang dimiliki Perseroan.

PP Presisi and Subsidiaries Obtain Financing Cooperation Facilities for Completion of the Cinere–Jagorawi Toll Road Construction Project Section 3

Jakarta, 07 June 2022 – PP Presisi (the Company) together with Subsidiary (PT LMA) obtained a Financing Cooperation facility in the form of a Kredit Modal Kerja (KMK) facility from PT Bank BNI (Persero) Tbk, for the completion of the Cinere–Jagorawi Toll Road Development Project Section 3 ± Rp. 770 billion with a total contract value of the Cinere–Jagorawi Toll Road Section 3 of Rp. 1.2 trillion.

“By obtaining the financing cooperation facility in the form of working capital facility, it will assist the Company in accelerating the project completion process which is planned to be completed in the early quarter of 4-2022 and indicates that PP Presisi has gained great trust from the banking sector in the construction of the Section 3 Cinere-Jagorawi Toll Road project which is expected can increase the competitiveness advantage of the Company as a Construction Services Company and Mining Services Company as the main contractor.” said Rully Noviandar as President Director of PP Presisi.

“What we know is that the Covid-19 Pandemic that has hit the whole world including Indonesia in the last 2 years has had an impact on all industrial sectors including the withdrawal of several infrastructure project tenders, the Cinere - Jagorawi Toll Road Project Section 3 is the only infrastructure project to be tendered in 2021. The toll road is part of the Jakarta Outer Ring Road (JORR) II Toll Road network that connects Kukusan-Cinere Depok for a length of 5.5 kilometers. So it is hoped that with the completion of section 3, the toll road (JORR) I will be connected to (JORR) II via the Depok–Antasari (Desari) Toll Road & Cijago Toll Road,” added Rully.

In the future, we will focus on construction and non-construction services through synergies with state-owned enterprises and the private sector, especially as mining service contractors by referring to the trend of nickel growth and increasing commodity prices with the Company's capacity and capabilities.
