### Kunjungan Kerja Komisi V DPR RI Ke Proyek Pembangunan Jalan Tol Cinere – Jogorawi Seksi III PP Presisi Percepat Penyelesaian Proyek Pembangunan Jalan Tol Cinere – Jagorawi Seksi III

**Jakarta, 26 Agustus 2022** – PP Presisi bersama dengan anak perusahaannya yaitu PT LMA sebagai kontraktor utama, percepat penyelesaian pekerjaan Pembangunan Jalan Tol Cinere Jagorawi Seksi III yang merupakan bagian dari Jalan Tol JORR II (“Jagorawi–Cinere–Serpong–Bandara”) dengan nilai kontrak sebesar Rp1,1triliun.

“Melihat track record yang dimiliki oleh PP Presisi dalam mengerjakan proyek-proyek strategis nasional seperti pembangunan jalan tol, bendungan, dermaga, bandara dengan kapasitas alat berat yang dimiliki berjumlah lebih dari 3.000unit dengan merk ternama, serta sumber daya manusia yang handal dibidang konstruksi, tentunya target penyelesaian proyek jalan tol sepanjang 5,5km tersebut dapat diselesaikan tepat waktu. Pembangunan Jalan Tol Cinere Jagorawi Seksi III memiliki tantangan tersendiri, dimana jumlah bangunan yang terdiri dari 10 jembatan, 2 JPO, 5 box traffic, 9 box drainase 7 gerbang tol, 2 simpang susun, 1 junction (total 8 ramp - 4 ramp dikerjakan KSO) dapat diselesaikan sesuai target dan menjadi pilot project bagi proyek-proyek jalan tol kedepannya” ungkap Rully Noviandar – Direktur Utama PT PP Presisi Tbk sekaligus Komisaris Utama PT Lancarjaya Mandiri Abadi.

Pada Jumat, 26 Agustus 2022 Komisi V DPR RI bersama dengan Perwakilan PUPR, BPJT maupun BUJT melakukan kunjungan kerja ke Proyek Pembangunan Jalan Tol Cinere – Jagorawi Seksi III untuk melihat langsung progress pembangunan jalan tol tersebut. Dalam kunjungan kerja tersebut, Rully Noviandar selaku Direktur Utama bersama dengan Jajaran Direksi PT PP Presisi Tbk turut mendampingi Anggota Komisi V DPR RI. Adapun salah satu agenda pembahasan penting yang didiskusikan dalam Kunjungan Kerja tersebut adalah terkait dengan rencana pembebasan lahan untuk dapat membantu percepatan penyelesaian proyek.

Dalam Kunjungan Kerja tersebut PP Presisi berkomitmen tidak hanya tepat waktu dalam menyelesaikan pekerjaan, namun juga berusaha untuk memberikan hasil dengan kualitas terbaik sesuai dengan standard yang telah ditentukan. “Proyek ini tentunya akan dapat selesai tepat waktu dengan dukungan seluruh pihak terkait, terutama kaitannya dengan pembebasan lahan. Kami harapkan hasil Kunker ini salah satunya dapat memberikan dampak pada progress pembebasan lahan yang akan diteruskan dengan percepatan progress proyek guna menyelesaikan pekerjaan kami tepat waktu”, tutup Rully.

### Working Visit of Commission V of the House of Representatives of the Republic of Indonesia to the Cinere – Jagorawi Toll Road Construction Project Section III

#### PP Presisi Accelerates Completion of the Cinere – Jagorawi Toll Road Construction Project Section III

**Jakarta, August 26, 2022** – PP Presisi together with its subsidiary, PT LMA as the main contractor, accelerated the completion of the Cinere Jagorawi Toll Road Section III construction which is part of the JORR II Toll Road (“Jagorawi–Cinere–Serpong–Airport”) with a value of contract amounting to Rp1.1trillion.

“Looking at the track record owned by PP Presisi in working on national strategic projects such as the construction of toll roads, dams, docks, airports with a capacity of more than 3,000 heavy equipment owned by well-known brands, as well as reliable human resources in the construction sector, of course the target for the completion of the 5.5km-long toll road project can be completed on time. The construction of the Cinere Jagorawi Toll Road Section III has its own challenges, where the number of buildings consisting of 10 bridges, 2 JPO, 5 traffic boxes, 9 drainage boxes, 7 toll gates, 2 interchanges, 1 junction (a total of 8 ramps - 4 ramps worked by KSO) can be completed according to the target and become a pilot project for future toll road projects,” said Rully Noviandar – President Director of PT PP Presisi Tbk as well as President Commissioner of PT Lancarjaya Mandiri Abadi.

On Friday, August 26, 2022, Commission V of the DPR RI together with representatives of PUPR, BPJT and BUJT made a working visit to the Cinere - Jagorawi Toll Road Development Project Section III to see firsthand the progress of the toll road construction. During the working visit, Rully Noviandar as the President Director along with the Board of Directors of PT PP Presisi Tbk accompanied the members of Commission V of the DPR RI. One of the important discussion agendas discussed during the Working Visit was related to the land acquisition plan to assist in accelerating project completion.

During the Working Visit, PP Presisi was committed not only to being on time in completing the work, but also trying to provide the highest quality results in accordance with predetermined standards. “This project will certainly be completed on time with the support of all relevant parties, especially in relation to land acquisition. We hope that the results of this work visit can have an impact on the progress of land acquisition which will be continued by accelerating project progress in order to complete our work on time,” concluded Rully.
