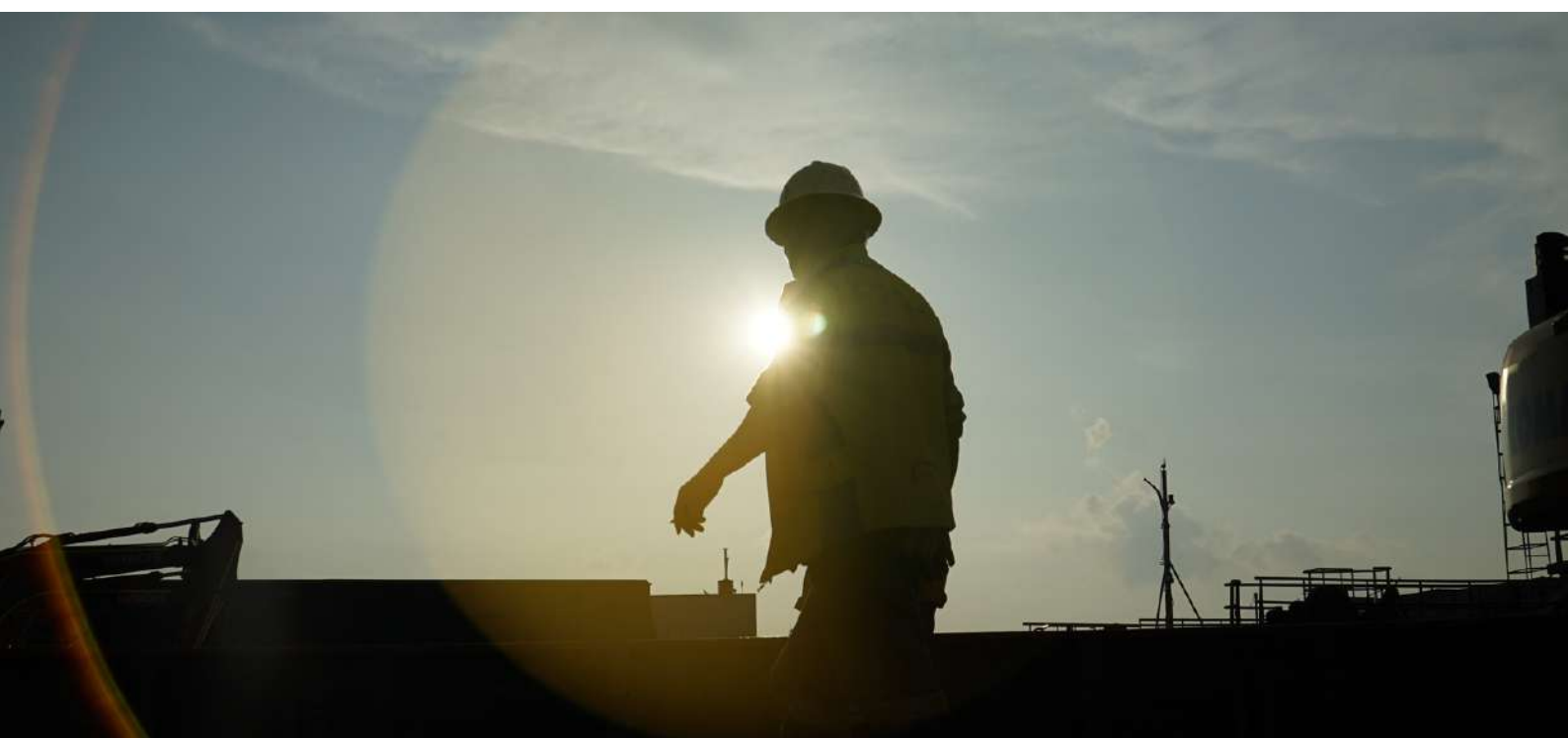
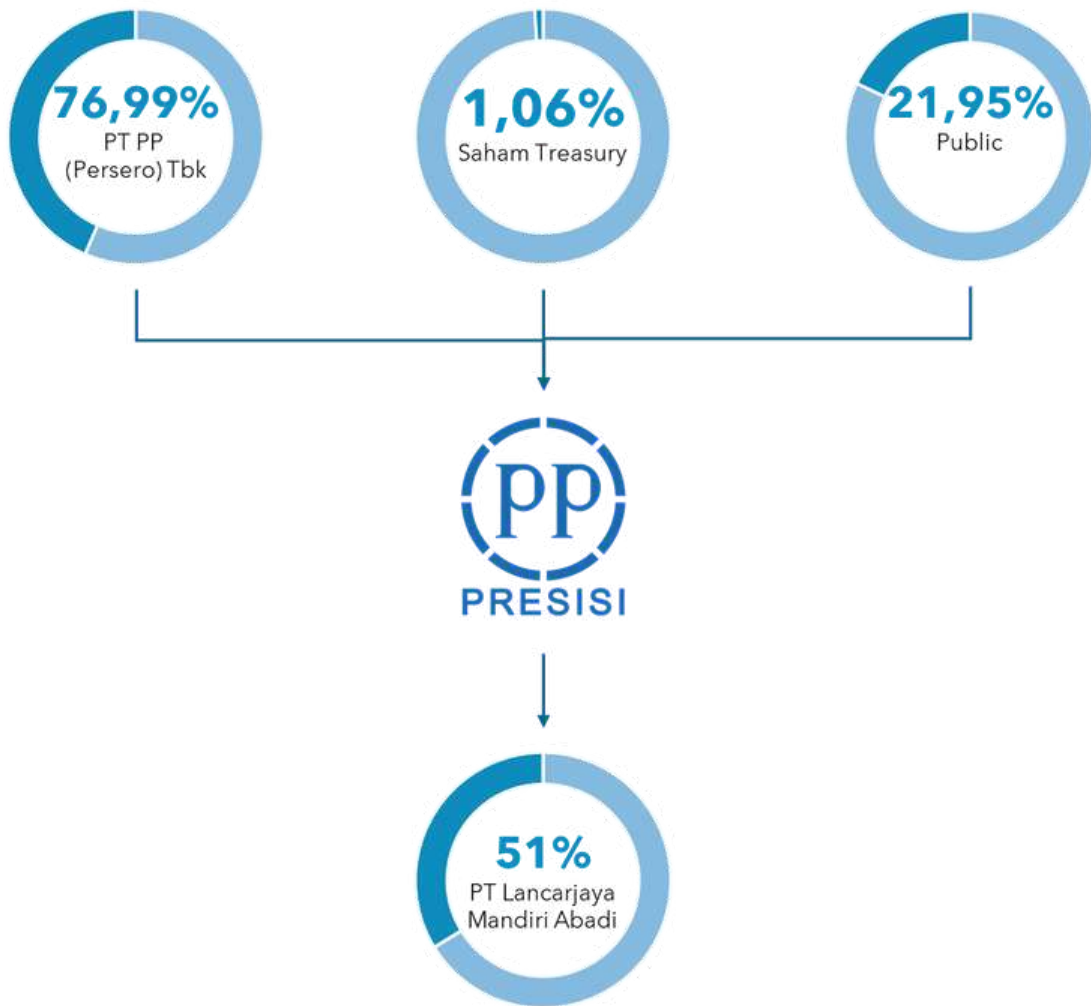

This listing effort is the culmination of a long journey of business transformation process that has been carried out by PP Presisi since 2013.

Initial Shares on the Indonesia Stock Exchange are equivalent to 23% of the Company's issued and fully paid capital after the Initial Public Offering (IPO).

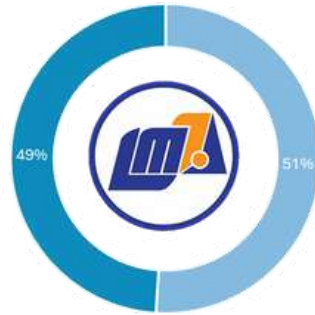

PT PP Presisi Tbk was established under the name PT Prima Jasa Alodua (PT PJA) on May 6, 2004 based on the notarial deed of Muhammad Chotib, SH and ratified by the Minister of Justice and Human Rights on July 1, 2005.

CONSTRUCTION & INVESTMENT

The main business focus of PT Primajasa Alodua is small-scale construction equipment rental service with a focus on developing light equipment, scaffolding, and managing heavy equipment owned by PT PP (Persero) Tbk.

2016



PT PP (Persero) Tbk acquired PT Prima Jasa Alodua, then changed its name to PT PP Peralatan Konstruksi (PP Alkon) in June 2014, and transformed into a heavy equipment-based construction service company with civil works projects such as toll road and dams.

2015



PT Primajasa Alodua developed its main business focus to become construction equipment rental services and medium-scale contract work with a focus on the development of heavy equipment, namely tower cranes and earth moving. PT PP Equipment Construction carries out business development by adding the Company's business lines, namely: Ready Mix to support and fulfill construction work.

2017



PT PP Peralatan Konstruksi changed its name to PP Presisi and acquired PT Lancarjaya Mandiri Abadi (LMA) for 51%.

June : PT PP made additional capital to PT PP Presisi

November : PT PP Presisi is listed on the Indonesia Stock Exchange (Indonesia Stock Exchange).

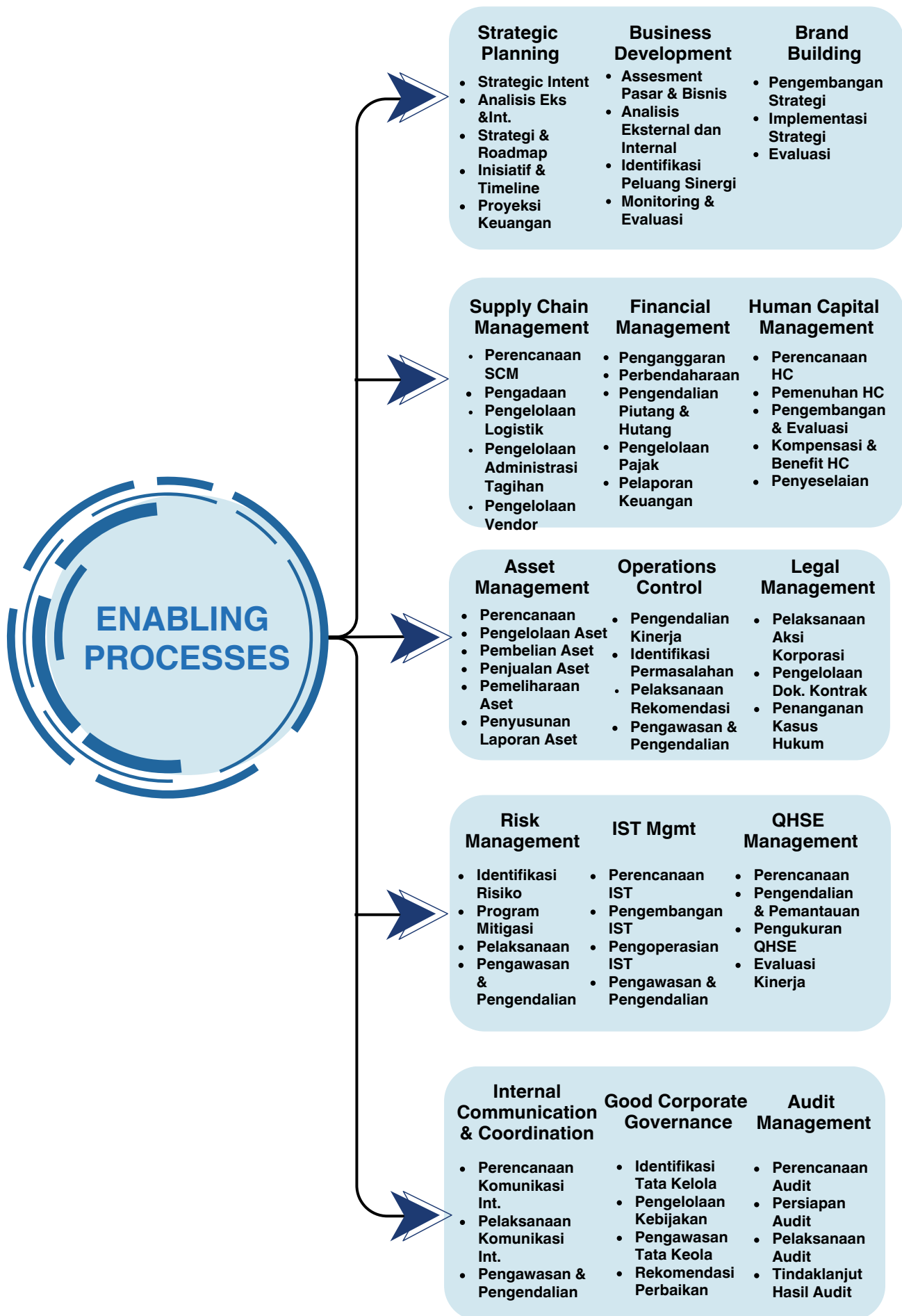
